D. Report from the <u>COMMITTEE ON PUBLIC SAFETY</u>, <u>JUDICIARY AND HOMELAND SECURITY</u>:

1. Recommending approval of a revenue-generating contract with one, two-year option to renew between the Charter County of Wayne and Martin's Towing & Auto Sales, Inc. (of Brownstown) in the estimated amount of \$150,000 to provide towing, storage and auction services initiated for citizens' assistance, abandonment and/or nuisance abatement seizures; the Sheriff advises that 4 proposals were received in response to 81 direct solicitations; after review, the Procurement Division recommends a dual award to Martin's Towing & Auto Sales, Inc. and J&T Crova Towing, Inc. as the two highest scorers meeting all bid specifications; Martin's Towing & Auto Sales, Inc. will subcontract a to-be-determined amount to Demark Marine Specialties (of Gibraltar) for to-be-determined services; the term of the contract will commence upon Commission approval through September 25, 2025; the revenue from the contract will be deposited into Account No. 263 31303 628035 (Sheriff-Drug Enforcemnt). Recommending approval of a grant award between the Charter County of Wayne and the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, for the 2022 Justice Assistance Grant in the amount of \$1,428,183, with no County match required, to distribute the funds to the Sheriff's Office and 16 municipal police departments, and to delegate authority to the County Executive to execute intergovernmental agreements with each of the municipalities to allow for the immediate release of funds; the Sheriff advises that the department's allocation will be used for training, support, equipment, outreach and grant administration; the term of the grant award is from October 1, 2021 through September 30, 2025; the revenue from the grant award will be deposited into Account No. 266 31697 529000 (JAG-2022). - 3. Recommending approval of Modification No. 1 to a grant award between the Charter County of Wayne and the Michigan State Police, Office of Highway Safety Planning, in the amount of \$1,123,025, with no County match required, for the 2023 Secondary Road Patrol and Traffic Accident Prevention program; Modification No. 1 increases the total amount of the grant award from \$893,234 to \$2,016,259; the term of the grant award remains from October 1, 2022 through September 30, 2023; the revenue from Modification No. 1 will be deposited into Account No. 101 33300 543000 (Sheriff-Secondary Roads). - 4. Recommending approval of Amendment No. 1 to a one-year memorandum of understanding (MOU) between the Wayne County Sheriff's Office and Third Circuit Court not to exceed \$408,349, extending the term of the MOU by one year, for deputies to ensure safety and security in juvenile courtrooms during trials or preliminary hearings; the Sheriff advises that the money is coming from a Raise The Age grant agreement between the Michigan Department of Health and Human Services and Third Circuit Court; Amendment No. 1 increases the total MOU not-to-exceed amount from \$364,177 to \$772,526; Amendment No. 1 extends the term of the MOU from October 1, 2021 through September 30, 2023; the revenue from Amendment No. 1 will be deposited into Account No. 286 31500 561010 (RTA-Sheriff). - 5. Recommending approval of the Fiscal Year 2023 Crime Victim Rights grant award between the Charter County of Wayne and the Michigan Department of Health and Human Services in the amount of \$1,327,274, with no County match required, to fund 13 victim advocates, one social worker, one project manager and two department supervisors in the Prosecutor's Office; the term of the grant award is from October 1, 2022 through September 30, 2023; the revenue from the grant award will be deposited into Account No. 282 22904 569000 (Victim Wtnss (P.Atty)). - 6. Recommending approval of the Fiscal Year 2022 Sexual Assault Kit Initiative grant award between the Charter County of Wayne and the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, in the amount of \$1,500,000, with no County match required, to fund costs for seven full-time Wayne County Sexual Assault Kit Task Force detectives; the term of the grant award is from October 1, 2022 through

September 30, 2025; the revenue from the grant award will be deposited into Account No. 101 22804 529000 (SAKI-2022). (2023-93-001)

7. Recommending approval of Modification No. 2 to a subrecipient agreement between the Charter County of Wayne and Research Triangle Institute, dba RTI International (of Research Triangle Park, NC), with no change in the dollar amount, extending the subrecipient agreement by six months, to test DNA evidence in unsolved Detroit homicide cases; the Prosecutor advises that the money is being drawn from a 2019 National Sexual Assault Kit Initiative grant to RTI International from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, in the amount of \$6,600,000; the amount of the subrecipient agreement remains \$50,000; Modification No. 2 extends the term of the subrecipient agreement from July 1, 2020 through March 31, 2023; the revenue from the subrecipient agreement will continue to be deposited into Account No. 101 22999 529000 (SAKI Advanced DNA Testing). Recommending approval of Modification No. 2 to a Coronavirus Emergency Supplemental Funding grant agreement between the Charter County of Wayne and the Michigan State Police, with no change in the dollar amount, extending the grant agreement by nine months, to eliminate the backlog of more than 1,800 not-in-custody warrants in the Prosecutor's Office, Screening & Warrants Division; the Prosecutor advises that the grant agreement covers the salaries of three part-time project consultant assistant prosecuting attorneys and three full-time law clerks, and the purchase of six laptop computers, and that the Michigan State Police received the grant from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, for prosecutors' offices to hire temporary, contractual staff to assist with the reduction or elimination of backlogs resulting from the pandemic; the amount of the grant agreement remains \$99,996, with no County match required; Modification No. 2 extends the term of the grant agreement from June 1, 2021 through September 30, 2023; the revenue from the grant agreement will continue to be deposited into Account No. 101 22988 529000 (Coronavirus Emergency Supplement Funding).
