October Highlights:

Environment of Care

- Patient Care areas were 100% for staff wearing N95 masks correctly from Q1 to Q3.
- Staff knowledge of what to do for Code Silver and Code Pink was 100% for all of 2022.
- Patient Care areas were free of power strips and extension cords for all of 2022.

Laboratory Services/Blood Transfusion committee

- From Jan-Sept 2022, Stroger transfused 6098 units of PRBCs.
- The transfusion reaction rate was 0.2% (the National Average is the same 0.2%)
- The new Trauma blood bank refrigerator was installed and went live on 11/08/22
- Two new blood bank analyzers are going through validation testing now.

HRO/Dyad Process of Care

- The CLABSI facility SIR is 0.50 compared to the National SIR of 0.983
- The CAUTI facility SIR is 0.502 compared to the National SIR of 0.793
- There have been Zero Hospital Acquired Pressure Injuries (PSI-03) from January 2022 YTD

October Highlights

Pharmacy

- Appropriate use of anticoagulants per protocol has been 100% compliant for 2022 YTD.
- Medications being locked and secured in refrigerators/cabinets has been 100% compliant for 2022 YTD.

Inpatient Care Coordination

- Q3 2022 Discharge disposition and delay of care was 10% with a benchmark of <25%.
- Observation cases with LOS >48hrs was 22% for Q3 2022 which is below goal of <25%.

Environment of Care

- Patient Care areas free of food and drink was 100% since June 2022
- Staff wearing N95 masks correctly was 100% since June 2022.
